Our flagship manmade surplus program is ExcessAccess.org, an online platform that matches in-kind donations with the wishlists of those nearby, keeping tons of useful materials out of the waste stream.

Our naturally abundant renewable resources programs include the GlobalCompostProject.org., which promotes the recycling of green waste and the benefits of carbon farming. Also, Our CleanWave Project, which collects waste fibers (hair, fur, fleece, etc.) and felts them into mats used in oil spills and in storm drains.
